Kwong Soo is a translation of the name of an ancient Chinese Emperor. The characters on the right and left hand side of the uppermost coin like element are Chinese characters representing money. The lowermost, or right hand coin like element bears, where visible, Japanese characters representing one unit of money.

Foreign Character Transliteration

The left hand, uppermost coin like element has an upper Chinese character representing the word Kwong, and a lower character representing the word Soo.
