Goods (Nice class & Statement)

- (1) Pre-recorded audio and video recordings, namely audio cassettes, video cassettes, and CDs and DVDs featuring music, education information, movies.
- (2) Souvenirs, namely booklets, postcards.
- (3) Collectibles, namely bookmarks, ornamental novelty pins, crests, key tags, decals and lighters, magnets, spoons and spoon rests, forks, letter openers, coins, patches, thimbles, bells, buttons, bumper stickers, stickers, matches, cloth and paper pennants, cloth and paper banners, cloth and paper flags, pins, Christmas ornaments, miniature replica buildings, oil paintings, decorative busts, plaques, book ends, photographic frames, wind chimes, zipper pulls, walking stick, paperweights.
- (4) Paper goods, namely writing pads, souvenir books, posters, paper shopping bags, postcards, photo albums, playing cards, placemats, calendars, cookbooks, address books, writing paper, guest books, notebooks, prints (namely art prints, photographic prints, litographic prints, colour prints and pictorial prints), greeting cards and paintings in water-colour, napkins, photographic prints, books.
- (5) Stationery, namely pencil cases, erasers, pencils, motion pen, rulers, writing pads, writing board, crayons, ball point pens, fountain pens, rubber stamps, paperweights; address books.
- (6) Textile goods, namely hats, caps, visors, oven mitts, tea towels, ties, aprons, linen bags, scarves, placemats, polo shirts, cardigans, t-shirts sweatshirts, turtle necks and tank tops for adults, youths and children, iron-on patches, tote bags, baby bibs, towels, table runners, pillows.
- (7) Jewellery, including charms, pendants, earrings, jewellery boxes, tie clip, necklaces, bracelets.
- (8) Toys, namely puzzles, balloons, piggy banks, shields and swords, sand castles, miniature replica castles, backscratchers.
- (9) Baggage, namely change purses, tote bags, purses, lunch bags, back packs, wallets.
- (10) Candy and cookies, including chocolate, toffee, maple sugar candy, and lolly pops, gingerbread.
- (11) Earthenware, ceramics, tinware and glass works, namely coffee mugs, beer-steins, shot glasses, shooters, toothpick holders, salt and pepper shakers, dishes (collectible and dinner), plates, coasters; spoon rests, pewter figurines, ashtrays, tin trays, ceramic tile, candy dishes, pot-pourri dishes, vases, bowls, decorative glass figurines, flower pots, suncatchers, perfume bottle, ice bucket, drinking glasses, wine glasses, beer glasses, champagne glasses, decanters, pitcher, serving tray.

- (12) Horological instruments, namely clocks, watches, travel alarms.
- (13) Illuminating wares namely, candles and candleholders, lamps.
- (14) Preserves and condiments, namely ginger, mustard, chutney, marmalade.
- (15) Beauty aids, namely bath salts, hair brush, perfume, body lotion, skin care preparations, bubble bath, body mist, aromatic candles.
- (16) Measuring instruments, namely measuring tapes, thermometers.
- (17) Casual, sports and dress clothing for men, women and children including sweaters, sweatshirts, jackets, vests, tunics, t-shirts, golf shirts, shirts, night shirts, turtleneck shirts, rugby shirts, baseball shirts, headwear (namely hats and baseball caps), children's rompers, dresses, tank tops, footwear (namely socks).
