Colour claim

Colour is claimed as a feature of the trade-mark. The box at the top of the mark featuring two Chinese characters is red. The two Chinese characters immediately below the red box are brown. The word "Sulwhasoo" is brown. The Chinese character below the brown-coloured Chinese characters is gold. The three Korean characters below the term "Sulwhasoo" are black.

Foreign Character Translation

The two Chinese characters within the red background box in the mark means "Korean traditional medicine" in English. The three Chinese characters immediately below the red background box in the mark these terms mean "Snow, Flower, Excellence," respectively in English. The three Korean characters beneath the word "Sulwhasoo" in the mark this has no meaning in a foreign language. The term "Sulwhasoo" cannot be translated from another language into English or French.

Foreign Character Transliteration

The two Chinese characters within the red background box in the mark transliterate to Han Bang. The three Chinese characters immediately

below the red background box in the mark transliterate to Sul Wha Soo. The three Korean characters beneath the word "Sulwhasoo" in the mark transliterate to Sul Wha Soo.

Goods (Nice class & Statement)

(1) Cosmetic preparations for bath and shower, namely, bath oils, bath salts, bath beads and bath powder;
