Colour claim

Colour is claimed as a feature of the trademark. Colour dark green is claimed for an oval logo behind the wording "FRATELLI MANTOVA SINCE 1905"; colour white is claimed for wording "FRATELLI MANTOVA SINCE 1905"; colours gold and dark green are claimed for the inner band surrounding the dark green oval logo; colours gold, dark green and light green are claimed for an outer edge of the oval logo in the shape of a wreath.

Foreign Character Translation

As provided by the Applicant, the translation of the words "FRATELLI MANTOVA" is "Mantova brothers".
