The third Chinese character "GUO" means "state". The fourth Chinese character "JI" means "boundary". The fifth Chinese character means "JIN" means "enter". The sixth Chinese character "KOU" means "mouth". The seventh Chinese character "BO" means "plentiful". The eighth Chinese character "LAN" means "view". The ninth Chinese character "HUI" means "meeting". The whole sentence consisted by the mentioned nine Chinese characters mean "CHINA INTERNATIONAL IMPORT EXPO".
