**Colour claim**

Colour is claimed as a feature of the trademark. The colours black, white and red are claimed as a feature of the mark. The letters "W", "I", and "K" are displayed in white, with the tittle on the letter "I" being in red. The stylized letter "X" is comprised of four shapes that resemble the letter "L", the top and bottom of which are in red, while the other two are in white. All of these elements appear against a black background of rectangular shape.
