- 14 (2) Jewelry; jewelry findings; jewelry cases; ornamental lapel pins; pins being jewelry; tie pins; tie clips; tie bars; cuff-links; shirt studs; badges of precious metal; costume jewelry; jewelry pins for use on hats; hat jewelry; decorative pins; key chains of precious metal; watches; watch bracelets; watch accessories, namely, watch parts; wristwatches; pocket watches; stop watches; watch straps and bands; watch chains and fobs; watch cases, namely, cases adapted for holding watches; presentation boxes for watches; clocks; timepieces; leather key chains; metal key chains and metal key rings; non-metal key chains and rings; plastic key rings.

production and distribution of musical sound recordings and audio and video recordings; production and distribution of non-downloadable prerecorded music, musical sound recordings and video recordings featuring music and entertainment, all online via a global computer network; production and distribution of musical and audio and video programs distributed across various platforms; publication of the editorial content of sites accessible via a global computer network; educational and entertainment services, namely, online non-downloadable animated videos featuring songs; entertainment in the nature of a live musical performer; entertainment in the nature of live performances by a musical artist; entertainment, namely, live music concerts; live performances featuring prerecorded vocal and instrumental performances viewed on a big screen; record production; music production; motion picture song production; recording studio services; entertainment, namely, personal appearances by a musician or entertainer; entertainment services, namely, live, televised and movie appearances by a professional entertainer; entertainment in the nature of live traveling tours by a professional entertainer featuring music; entertainment services, namely, presenting non-downloadable ringtones, pre-recorded music, video and graphics to mobile communications devices via a global computer network and wireless networks; organizing, arranging, and conducting virtual musical concerts, music award ceremonies and music contests.
