Colour claim

Colour is claimed as a feature of the trademark. The colors dark blue, white, and blue are claimed as a feature of the mark. The mark consists of a dark blue square. Inside the square, there is a small blue square to the left of the dark blue square, followed by two white thick "L" shaped lines facing one another (one to the top right of the dark blue square and one to the bottom left), both connected by the small blue square at the top left. There is a thick white line in the center of the two "L" shaped lines. The combination of the small blue square and the thick white lines resemble the letter "Q". Under the dark blue square, there are the letters "R" "I" "Q" in blue to the left and the words "INTELLIGENTLY REINSURED" in dark blue to the right.
