Instructions for corporations – Request for information

Your corporation can send this template to its individuals with significant control (ISC), its shareholders and any other person that the corporation has reasonable grounds to believe may have relevant knowledge on an ISC, or of another person who may have relevant knowledge on such an individual.

Note: This template may need to be adjusted according to your corporation's situation. It is not meant to cover all scenarios.

How to use this template

- 1. Add recipient information on page 1.
- 2. Add the corporation's name where indicated in paragraphs 1 and 3.
- 3. On the last page, add the corporation's address or email address where this request for information needs to be returned to.
- 4. Send this request for information to:
 - a. ISCs of the corporation;
 - b. shareholders of the corporation; and
 - c. any other person that the corporation has reasonable grounds to believe may have relevant knowledge with respect to an ISC, or of another person who may have relevant knowledge about an ISC.
- Once the completed requests for information are returned to you, record the ISC information in the corporation's ISC register and/or contact the person(s) indicated in Part C, as applicable.

Reminder: don't forget to file the ISC information with Corporations Canada annually and within 15 days of a change in your ISC register. You can file it on Corporations Canada's Online Filing Centre.

Request for information – Individuals with significant control

In accordance with the *Canada Business Corporations Act*, **[Corporation name]** is required to maintain a register of individuals with significant control (ISC register).

An individual with significant control (ISC) is someone who owns or controls a corporation. This individual:

- owns, controls or directs 25% or more of shares individually, jointly or in concert with one
 or more individuals:
- has control in fact over the corporation without owning any shares; or
- meets a combination of any of these factors.

You are receiving this request for information because:

- you are listed as an ISC in the corporation's ISC register;
- you are a shareholder of the corporation; or
- the corporation has reasonable grounds to believe that you may have relevant knowledge on an ISC or on another person who may have relevant knowledge on an ISC.

As of January 22, 2024, [Corporation name] is required to file the information about its ISCs with Corporations Canada. Some of the ISC information will be made available to the public.

The ISC information provided in Part B will be filed with Corporations Canada and the following ISC information will be made public on Corporations Canada's website:

- full legal name;
- residential address (Note: If you do not want your residential address being made public, you must provide an address for service in Part A and the address for service will be made public instead);
- start date of control (for example, the date on which 25% or more of the shares were purchased);
- end date of control, if applicable (for example, the date on which you sold their shares); and
- description of how you are an ISC.
