1. Pursuant to the 4 April 2009 Canada Gazette, Part I, we enclose herein the submissions of Bell Aliant Regional Communications and Bell Canada (collectively, the Companies) in respect of Notice No. DGTP-004-09, Petitions to the Governor in Council concerning Telecom Decisions CRTC 2008-117 and CRTC 2008-118, Telecom Regulatory Policy CRTC 2009-34, and Telecom Order CRTC 2009-111.
