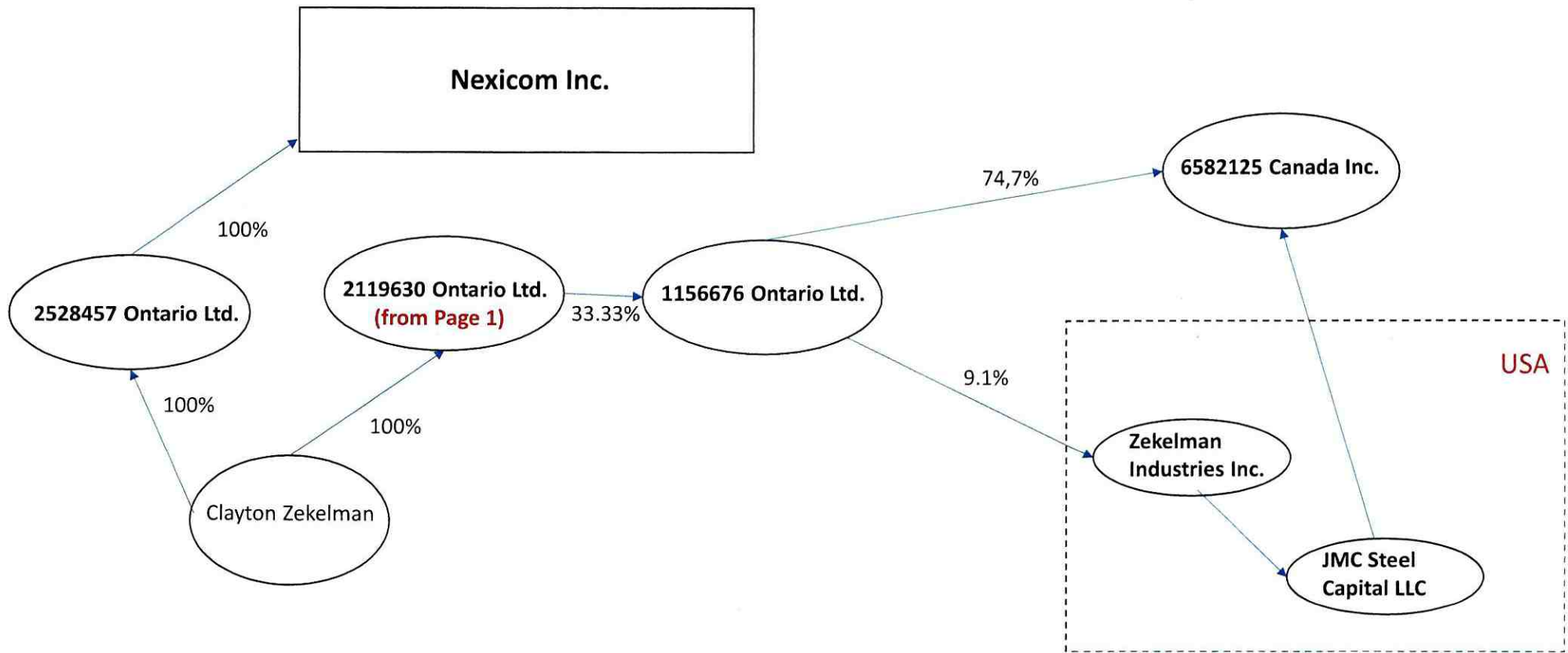

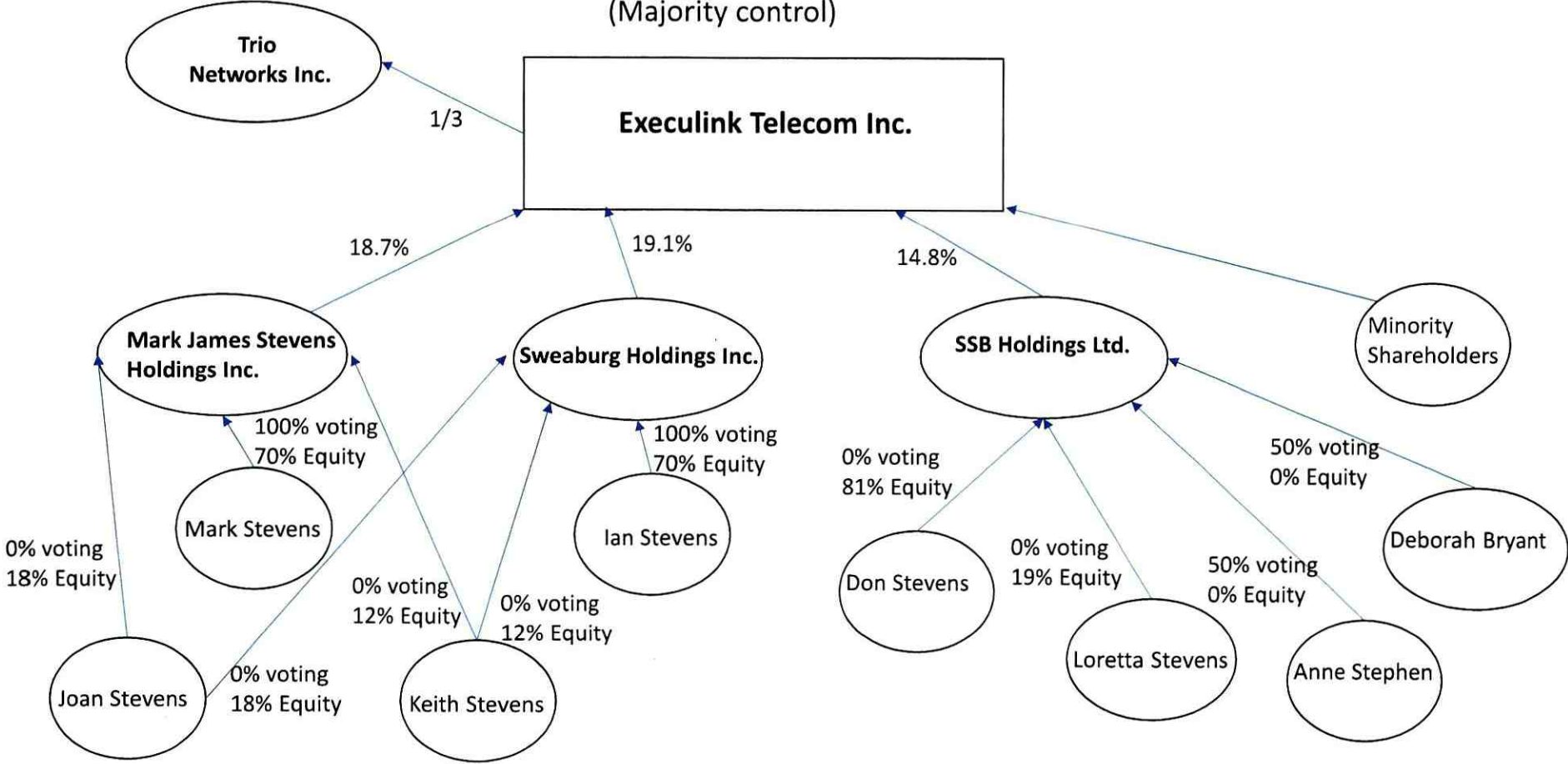
Beneficial Ownership Information on Nexicom (page 1)



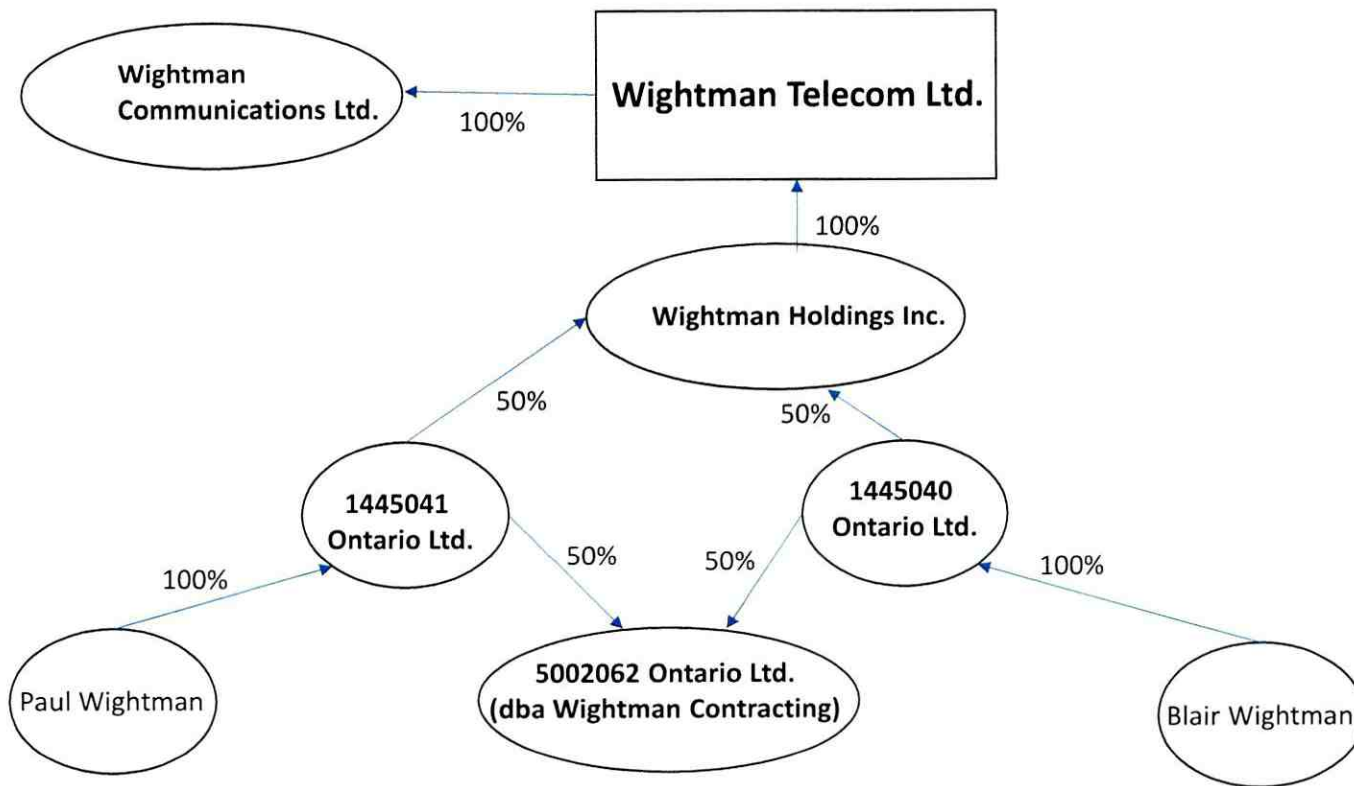
Beneficial Ownership Information on Nexicom (page 2)

NE&W SPC Inc.

NE&W is a special purpose consortium that is being formed specifically to enable joint bidding in the upcoming 3800 MHz spectrum auction. The Partners are: Nexicom Inc., Execulink Telecom Inc., and Wightman Telecom Ltd. They each control 1/3 of the SPC. The Bidder acts on behalf of the 3 Shareholders so no single shareholder has effective control by itself.

Nexicom Inc.

Nexicom Inc., is controlled (100%) by 2528457 Ontario Limited which in turn is controlled (100%) by Mr. Clayton Zekelman. Please refer to the accompanying beneficial ownership powerpoint chart included in this application in support of Form 2.

Nexicom is a 1/3 owner of NE&W SPC Inc. which is the Applicant for the 3800 MHz spectrum auction.

Execulink Telecom Inc.

Execulink Telecom Inc., is majority controlled by Mark James Stevens Holdings Inc. (18.7%), SSB Holdings Ltd. (14.8%) and Sweaburg Holdings Inc. (19.1%). Each of these 3 holding companies is respectively controlled by Mark Stevens, Don Stevens and Ian Steven, and other individuals. The balance of shares of Execulink is held by minority shareholders. NE&W SPC Inc.

NE&W is a special purpose consortium that is being formed specifically to enable joint bidding in the upcoming 3800 MHz spectrum auction. The Partners are: Nexicom Inc., Execulink Telecom Inc., and Wightman Telecom Ltd. They are telephony SILECs (Small Incumbent Local Exchange Carriers) in Ontario. Each operates in its own territory and exclusively of each other and often collaborate closely given their relatively small sized operations and are also part of the Independent Telecommunications Providers Association (ITPA), which represent the 21 independent SILECs across Canada.

The special purpose corporation will be the official applicant for the auction representing its 3 owners (equal shareholdings). There will be no direct competition between the 3 partners should the SPC obtain spectrum licences in the auction. Each partner has its own unique operations and unique sales & marketing activities.

Neither the Applicant nor its 3 Associates have contravened the collusion rules set out in the Framework.

Nexicom Inc.

Nexicom Inc., is controlled (100%) by 2528457 Ontario Limited which in turn is controlled (100%) by Mr. Clayton Zekelman.

Nexicom is a 1/3 owner of NE&W SPC Inc. which is the Applicant for the 3800 MHz spectrum auction. Nexicom operates independently of its 2 Associates in the Consortium.

Neither the Applicant nor its 3 Associates have contravened the collusion rules set out in the Framework.

Execulink Telecom Inc.
