

Mandatory examination frequencies by sector and device type

This list contains mandatory examination (inspection) frequencies by sector and device type, as well as the most common device types and exclusions. The trade sector descriptions are not exhaustive.

Dairy

Includes the sale or purchase of raw milk, cream or other dairy products at the wholesale level. These products are often used to manufacture and process butter, cheese, pre-packaged milk, ice cream, whey products, etc. Does not include dairy products sold directly to consumers.

Weighing machines	2 years

Common devices used in this sector include platform, vehicle and computing scales.

Common exclusions: Farm tanks and scales used to measure butterfat, lactose and protein content. Meters used for milking cows.

Downstream petroleum

Includes refined petroleum products and liquid alternative fuels bought and sold at the wholesale level between petroleum refineries, gas processing facilities, wholesalers, retailers and commercial customers.

Common devices used in this sector include bulk meters as well as platform, vehicle, railway, mass flow and gravity meters.

Fishing

Includes the wholesale trade of finfish, shellfish, marine vegetation and marine animals caught from the ocean, inland waters or aquaculture farms, and the products and by-products of their processing. Excludes the retail trade of fish and seafood.

Any device	1 year

Common devices used in this sector include platform, vehicle, computing and crane scales.

Forestry

Includes the commercial sale of logs, lumber, paper, treated recycled paper, and wood by-products (wood chips, particle board, etc.). Does not include methyl alcohol and wood resins.

Common devices used in this sector include platform, vehicle, railway, computing and conveyor belt scales.





Grain and field crops

Includes cereal grains, oil seeds, grain corn, wheat, forage, dry field peas, beans, and their corresponding seeds, feed grains and other animal foods processed by feed mills. Grain storage services offered in grain elevators are also included.

seed plants, etc.)	

Common devices used in this sector include platform, hopper, vehicle and railway scales.

Common exclusions: Moisture meters and protein analyzers.

Mining

Includes metal and non-metal ores, refined ores and their transformed products, as well as refined precious metals and precious stones. Mining does not include scrap metal, or products from the subsequent refining of precious metals and precious stones. Sand, gravel, stone and concrete are excluded when used for construction.

Any device	2 years

Common devices used in this sector include platform, vehicle, railway, hopper, crane and conveyor belt scales.

Common exclusions: Scales used exclusively in the wholesale trade of gold, silver or diamonds, after initial refining.

Retail food

Includes the buying and selling of retail foods at grocery stores, supermarkets, delicatessens, ethnic food stores, natural food stores, butcher shops, farmers' markets, fish and seafood retailers, fruit and vegetable retailers, coffee retailers and specialty candy and nuts retailers.

Any device	5 years

Common devices used in this sector include point-of-sale, computing, platform and overhead rail scales.

Retail petroleum

Includes liquid refined petroleum products (gasoline, diesel, propane, etc.) and liquid alternative fuels (hydrogen, ethanol, etc., when used as the only energy source of a vehicle) bought and sold at the retail level.

Propane meters	1 year
Devices other than a propane meter	2 years

Common devices used in this sector include bulk meters, gasoline and diesel dispensers, propane meters, refuellers, as well as platform and vehicle scales.
