

Principal Holders of Rogers Communications Canada Inc.

Rogers Communications Canada Inc. is a wholly-owned subsidiary of Rogers Communications Inc. (“RCI”).

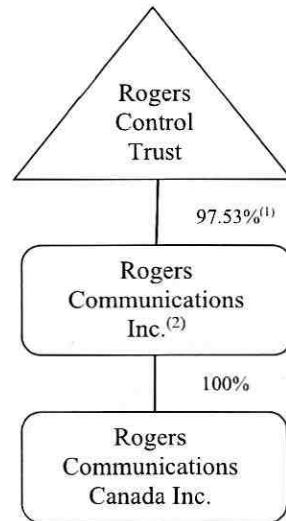
Voting control of RCI is held by the Rogers Control Trust. The trustee of the Rogers Control Trust (the “Trustee”) is the trust company subsidiary of a Canadian chartered bank and members of the family of the late Ted Rogers are beneficiaries. As of February 22, 2022, the Rogers Control Trust and private Rogers family holding companies controlled by the Rogers Control Trust together owned 108,403,398 Class A Voting Shares of RCI, representing approximately 97.53% of RCI’s outstanding Class A Voting Shares, and 38,938,700 Class B Non-Voting Shares RCI, representing approximately 9.89% of RCI’s outstanding Class B Non-Voting Shares.

The Rogers Control Trust holds voting control of RCI for the benefit of successive generations of the family of the late Ted Rogers. The equity of the private Rogers family holding companies is owned by members of the Rogers family and trusts for their benefit. The governance structure of the Rogers Control Trust comprises the Control Trust Chair, the Control Trust Vice-Chair, the Trustee, and a committee of advisors (the “Advisory Committee”). The Control Trust Chair acts as the representative of the controlling shareholder in dealing with RCI and votes the Class A Voting Shares held by the private Rogers family holding companies in accordance with the estate arrangements. The Control Trust Vice-Chair assists the Control Trust Chair in the performance of his or her duties and both are accountable to the Advisory Committee.

Currently, Edward S. Rogers is the Control Trust Chair and Melinda M. Rogers-Hixon is the Control Trust Vice-Chair. The Advisory Committee members are appointed in accordance with the estate arrangements. The current members of the Advisory Committee are: Lisa A. Rogers, Edward S. Rogers, Melinda M. Rogers-Hixon, Martha L. Rogers, and David A. Robinson (Rogers family members); Alan D. Horn, Thomas I. Hull and John H. Tory (trustees of a trust for the benefit of Rogers family members); and Philip B. Lind.

Principle Holders of Rogers Communications Canada Inc.

Rogers Control Trust (RCT) holds voting control of Rogers Communications Inc. (RCI). The following summary organization chart depicts the control structure of RCI.



- (1) The RCT and private Rogers family holding companies controlled by the RCT together own:
 - (a) 108,403,398 Class A Shares, representing approximately 97.53% of the outstanding Class A Shares, and
 - (b) 38,938,700 Class B Shares, representing approximately 9.89% of the outstanding Class B Shares.
- (2) RCI is publicly traded on the Toronto Stock Exchange (TSX: RCI.a and RCI.b) and on the New York Stock Exchange (NYSE: RCI).

ⁱ 891131 Ontario Inc. owns a property known as 150 Dundurn Street South, Hamilton, ON. This property is currently home to Cable 14 a division of TV Hamilton Limited. Cable 14 operates a community television station. TV Hamilton is jointly owned by Cogeco Communications Holdings Inc. and Rogers Communications Canada Inc.

ⁱⁱ 7211431 Canada Inc. is the entity created as a result of the joint venture between Rogers and Bell MTS for the Manitoba joint network. Rogers holds 50% and Bell MTS holds the other 50% interest in the company. 7211431 Canada Inc. acts as bare trustee for the network and holds the legal title of the assets contributed by Rogers and Bell MTS for the joint operation of network.

ⁱⁱⁱ In order to provide full disclosure to other applicants of Roger's ownership interest in an entity that holds radio spectrum licenses, Rogers is disclosing its 50% ownership interest in Orion Wireless Partnership (formerly Inukshuk Wireless Partnership (IWP)). However, Rogers does not consider that this ownership interest makes Orion Wireless Partnership an "affiliate" of Rogers within the meaning of that term in section 9.1 of the Licensing Framework. Since a competitor of Rogers, Bell Canada, owns the other 50% interest in Orion Wireless Partnership, Rogers does not control Orion Wireless Partnership. Nor does Rogers have the ongoing power or ability to determine or decide the strategic decision-making activities of Orion Wireless Partnership, or to manage or run its day-to-day operations, which would be necessary to establish control in fact of the partnership.

^{iv} Glentel Inc. is one of Canada's largest multi-carrier retailers of wireless telecommunications services and products. Glentel is headquartered in Burnaby, BC, and operates retail stores across Canada under the banners WIRELESSWAVE/WAVE SANS FIL, Tbooth wireless/la cabine T sans fil, and WIRELESS etc./SANS-FIL etc. Glentel offers a choice of cellular brands including Rogers, Bell, Fido, Virgin, ChatR, Lucky, and SaskTel, through stand-alone stores, retail malls and Costco Wholesale stores across Canada. Rogers Communications Inc. indirectly holds a 50% interest in Glentel Inc. and BCE Inc. holds the other 50%. Rogers does not control Glentel Inc. and does not have the ongoing power or ability to determine or decide the strategic decision-making activities of Glentel Inc., or to manage or run its day-to-day operations, which would be necessary to establish control in fact.
