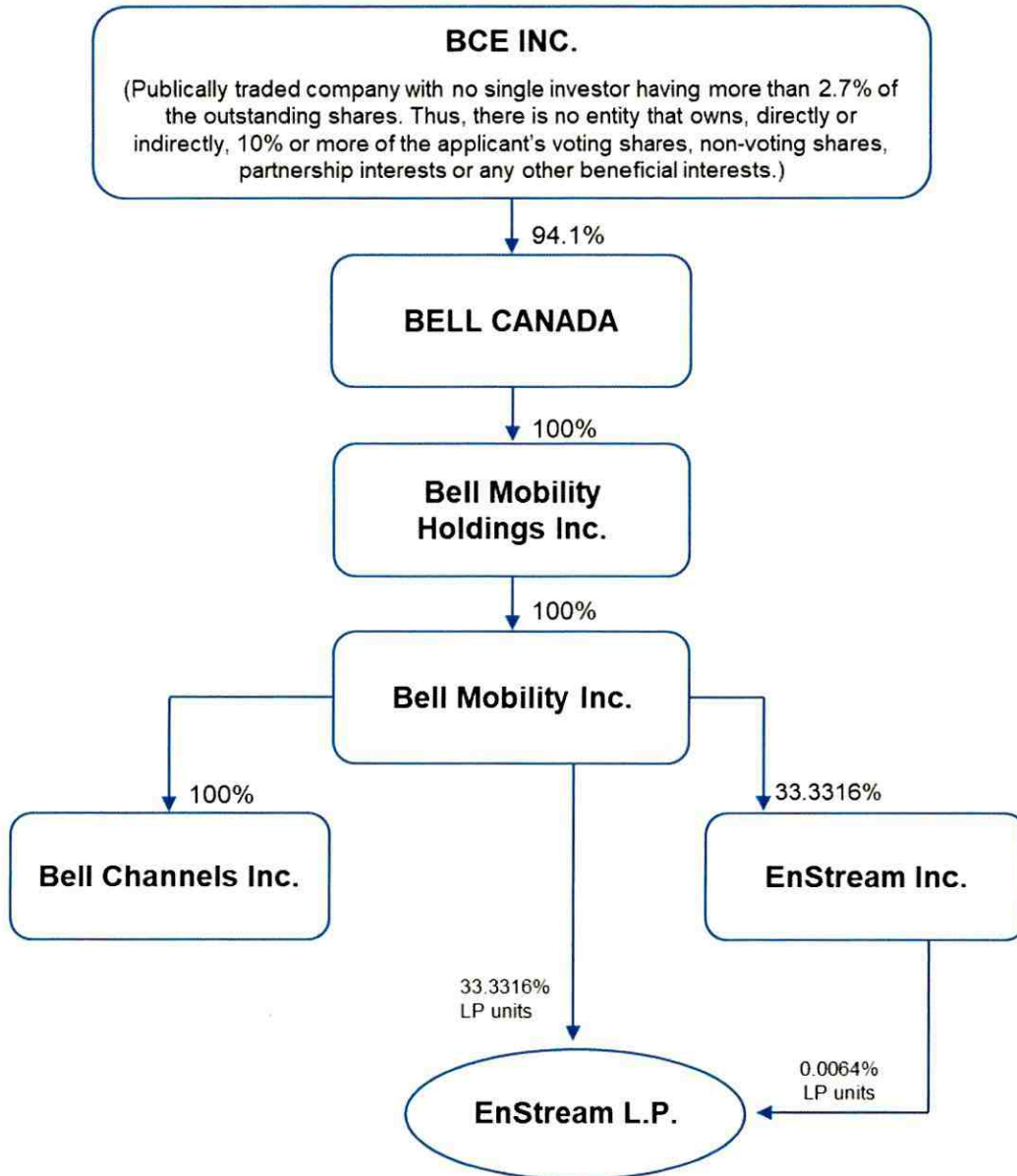


**Form 2: Beneficial Ownership**
